Extended Cookie Policy

Pursuant to the European Regulation 2016/679 (hereinafter referred to as “GDPR”) and the national legislation, BAZR S.p.A (Hereinafter, “BAZR” or “Controller”) provides, as the data controller¹, the following information regarding the cookies installed on the domain <https://www.bazrlive.com/> and its subdomains (hereinafter, also, “Site”).

What are cookies and why are they used

A cookie is a short string of text that is sent to your browser, and eventually saved on your computer or mobile device, each time you visit a website allowing, in addition, to collect information about your browsing on that website. Cookies can be stored permanently on the computer or mobile device used for browsing or have a variable duration (so-called “**persistent cookies**”), but they can also vanish when closing your browser or have a limited duration (so-called “**session cookies**”). Cookies may be installed by the website you are visiting (so-called “**first-party cookies**”) or they may be installed by other website servers (so-called “**third-party cookies**”).

Types of cookies used and purposes

✓ Statistical cookies

For the purpose of using third-party statistical cookies, the user’s consent is not required.

In particular, the Controller uses cookies from the Google Analytics platform to collect aggregate information regarding the use of the site by users (number of visitors, pages visited, time spent on the site, etc.). For the use of such cookies, the Controller has adopted tools that reduce the identifying power of the cookies (IP address masking) and tools to not cross reference the collected information with other information that Google already knows.

Property of cookies used on the Site

³ For the purposes of this notice, the term “processor” means “a natural or legal person, public authority, agency or other body which processes personal data on behalf of the controller” (Art. 4, number 8, GDPR).
